

Attorney Ennis updated the Board on the progress of their population limitation exemption application, reporting that they are nearing completion. The community impact assessment and employment verification have already been submitted. However, they are still awaiting the required public hearings conducted by the Tamuning Mayor's office. The first hearing is scheduled for October 3rd, with a second hearing set for October 10th.
